What is Redetermination?

Redetermination (REDE or renewal) is the annual process of reviewing your eligibility for the Medicaid program. Medicaid enrollees receive forms in the mail from the Illinois Department of Healthcare & Family Services (HFS). You must complete your paperwork by the deadline to keep your Medicaid health care coverage.

What Can You Do?

1 Keep your mailing address up to date

Make sure your mailing address is up to date to receive your renewal paperwork. Update your address in 2 ways:

- Update your address online at abe.illinois.gov (click on "Manage My Case")
- Call the HFS hotline: 877-805-5312
- 2 Know your redetermination date

Everyone's REDE date is different. Find your rede date in 2 ways:

- Online at ABE.Illinois.gov
 Click on "Manage My Case" and look under "Benefit Details" tab
- By Phone: 1-855-828-4995 Available 24 hours a day in English and Spanish.
- 3 Complete and submit your REDE paperwork
