CountyCare Provider Updates

Dear CountyCare Providers:

CountyCare is providing this 90-day notice to all in-network providers of its intent to limit the number of in-network providers for Coronary Artery Bypass Grafting and oncology treatment services (i.e. chemotherapy) beginning Monday, November 14, 2016.

Authorization of Coronary Artery Bypass Grafting (CABGs) will be limited to in-network providers who are to know to perform a significant number of CABG procedures on a Medicaid population as reported by the Illinois Department of Public Health (see http://www.idph.state.il.us/about/hfpb/HospProf_ABR.htm). Using calendar year 2014 data, the last complete year where data are available, the following in-network providers will be authorized for chemotherapy services starting November 14th:

Also beginning November 14th, authorization of oncology treatment services (i.e. chemotherapy) will be limited to in-network providers who have Commission on Cancer certification.
