Update to Prior Authorization (PA) Look-Up Tool (formerly called CPT Look up)- Updated January 11, 2024

As CountyCare continues to strive for ways to streamline and improve operations, we have created a new Prior Authorization Lookup tool (formerly called the CPT Lookup tool) to improve your ability to find prior authorization requirements at the procedure code level. The new tool includes the following tabs:

- **New Instructions on Use**-this tab provides instructions and updates
- **New Search Lookup Tool**- can search for any codes within the PA Look up Tool (**Must download a copy of the document in order use this feature**) [See here for instructions PA-Look-Up-Tool-FAQ-2024](#)
- **All Codes** tab: listing of the current PA requirements by procedure/service code- Can still search on this tab
- **Separated Specialty Tabs**: breaks out the code that are relative to a specific specialty- Includes codes and PA requirements for each specialty groups of services
 - SUPR Providers- behavioral health and substance use
 - **New** Dental for dental procedures
 - **New** NCH for Oncology and Cardiology specialty care
 - **New** eviCore for durable medical equipment
- **New Deleted and Discontinued Codes**: Based on the periodic AMA and CMS changes to CPT codes and CMS makes changes to HCPCS codes. This includes deleted and discontinued CPT and HCPCS codes entirely.
