New Member Population January 2024

Effective January 1, 2024, members participating in Healthcare and Family Services' **Health Benefits for Immigrant Seniors** (HBIA/HBIS) programs, will be transitioning into Medicaid Managed Care. Health Benefits for Immigrant Adults (HBIA) and Health Benefits for Immigrant Seniors (HBIS) are programs for people who are 42 years old or older, meet income guidelines, and are not eligible for Medicaid due to immigration status. CountyCare anticipates welcoming an additional 40,000 members in "CountyCare Access" between January and April 2024. Enrollment into both programs remains **paused** so no new applications should be submitted. Similar to other populations enrolled in managed care, there are some members who will remain in fee-for-service because they are excluded from managed care. Those are members with TPL or on spenddown (HBIS only).

CountyCare is the only Medicaid health plan that offers covered services at no-cost to HBIA/HBIS members.

Covered Services:


Doctor and hospital care	Lab tests
Rehabilitative services such as physical and occupational	Home health, mental health, and substance use services

Kidney and stem cell transplant services	Post acute care up to 90 days at skilled nursing facilities*
Prescription drugs	Dental, transportation, and vision services

^{*}For post-acute rehab benefits occurring at Nursing Facilities, Hospitals, or Rehab Hospitals, authorization is always required, this includes participating providers. Please ensure that prior authorization is requested when an HBIA/HBIS member requires post-acute rehab services.
